

Terms and Conditions - Ticket Purchaser and Home Builders Association of Wayne & Holmes Counties' 2025 Parade of Homes

1. General Information:

- a. These terms and conditions govern the purchase and use of tickets for the Home Builders Association of Wayne & Holmes Counties' (HBA) 2025 Parade of Homes ("Event").
- b. By purchasing a ticket, you agree to comply with these terms and conditions.

2. Ticket Purchase:

- a. Tickets can be purchased online through our website, <https://whhba.com>. The HBA will not share or sell the information you provide to us via this website. This information will be used only to process your ticket purchases. Ticket purchases are submitted over a secure connection. Nevertheless, no data transmission over the Internet can be guaranteed to be completely secure. Thus, we cannot ensure or warrant the security of any information you transmit to us. The HBA expressly disclaims any liability for disclosure of any information due to errors in transmission or the unauthorized acts of third parties.
- b. Tickets can not be canceled after completion of purchase. Tickets are non-transferable and non-refundable, unless otherwise specified. Tickets can not be redeemed for cash, credits, or any other benefits.
- c. The HBA reserves the right to limit the number of tickets purchased per person or per transaction at our discretion.
- d. Prices and availability of tickets are subject to change without prior notice.

3. Ticket Usage:

- a. Each ticket is valid for a single entry to the Event during both weekends.
- b. Tickets must be presented in their original form (printed or digital) for entry.
- c. Unauthorized duplication or resale of tickets is strictly prohibited and may result in the cancellation of the ticket without refund.
- d. Lost or stolen tickets will not be replaced.

4. Event Guidelines:
